COMPLETE TIMELINE

Date	Event
September 2012	Attends seminar, first meets the guru
October 2014	Gets 8 certifications. Gives guru \$100+ million in ideas; impresses him with extraordinary gifts

Date	Event
November 2014	Applies for job. Comes back from event, surveillance begins immediately
November 10, 2014	First "click" heard in brick wall
November 14, 2014	Finds first camera; it retracts into wall and vanishes
2014-2015	Business systematically destroyed; clients called and turned against him
September 2015	Protection order denied—judge rules surveillance exists but can't prove who did it
October 2015	Confronts guru; he admits stalking, mocks love life, says: "You're not going anywhere"
2016-2017	Hacked devices escalate; home, car, phone, computer, TV all compromised
2017	Lost home: first of ten moves to escape surveillance
2014-2026	Surveillance continues uninterrupted—follows to 9 of 10 locations
March 5, 2026	<i>THE STALKER'S PROTOCOL</i> published

THE EVIDENCE

What He Has	What He Doesn't Have
✓ 247 videos of bug detectors signaling devices	✗ A physical bug in his hand
✓ Recording of 30 clicks in 30 minutes	✗ The one he found—it retracted and vanished
✓ RF signal detector readings	✗ Criminal charges (impossible without device)
✓ Non-linear junction detector evidence	✗ No money to fight in court or for lawyers
✓ Proof of man-in-the-middle attacks	✗ No evidence directly linking to guru
✓ Guru's own admission to his face	✗ No law enforcement willing to help
